

AIM STATEMENT

Ensure 95% of patients with an OUD in Williams Lake and its surrounding areas up to 80kms who present to Cariboo Memorial Hospital Emergency Room looking to start OAT will have access to a Suboxone Induction, contact with a Community Crisis Response Nurse and an appointment at Cornerstone Clinic within 72 hours by December 2020.

BACKGROUND

Rural/Remote communities have limited access to typical healthcare routes:

- 1 OAT clinic serving 80 km range
- Limited number of GPs
- Limited access to substance use services/treatment

CHANGE IDEAS TESTED

- Ensuring Suboxone is on hand in ER
- Creating Referral Pathway to Cornerstone Clinic
- ER Doctor Training
- ER and Mental Health Nurse Training

FINDINGS

- Having Suboxone readily available in the ER was not enough
- · Each patients journey is individuals and should be treated as so
- Regardless of the provincial work that is being done to reduce stigma. There is still stigma for people living with substance use disorders and often it is a barrier to them accessing preventive care and then they end up in emergency rooms.

Steps to complete

- 1. Substance Use Disorder Intake Blood Work Send also to Cornerstone Clinic
- 2. COWS assessment
- Ask client if they want to engage in Mental Health Support
 If Yes Contact CCRT to talk to patient about further Mental Health Supports, and then continue
 with ER Doctor Assessment
 If No Continue with ER Doctor Assessment
- 4. Start Suboxone Induction
- 5. Complete next page and Fax referral to Cornerstone.
